CONCEPT NOTE

Background and Objectives

- 1. Asia Development Alliance (ADA) is a joint initiative of national and sub-national platforms of civil society organizations (NPs) in Asia engaged in international development issues in order to promote more effective international cooperation and solidarity among CSOs in partnership with campaign umbrella networks such as GCAP and like-minded international development CSOs or networks and relevant UN bodies in the context of Post 2015/MDGs development agenda setting process.
- 2. The proposed theme of the ADA 2013 is to "Asian Voice for the World We Want 2015" which emphasizes the importance of solidarity among NPs in Asia in building collectively global vision and strategies in terms of engaging in global processes such as Post 2015/MDGs and other related processes. The theme also implies the strategic partnership with existing campaigns on poverty eradication and inequality such as the Global Call to Action against Poverty (GCAP), Social Watch, LDCs Watch, etc.
- 3. The ADA 2013 will take place in Bangkok, Thailand for 3 days from 31 January to 2 February starting in the Thursday afternoon of 31 Jan. 2012 and closing in the Saturday afternoon of 2 Feb. 2013. The venue for the meeting on 1 Feb (Friday) will be the UNESCAP Building (1 Feb) and the rest will be at Hotel De' Moc www.hoteldemoc.com near the UNESCAP building.
- The idea of ADA was conceived and developed further at a series of informal consultations during the meetings where some representative of national platforms met including the Regional Consultation on Human Rights and Development (Bangkok, Aug. 2011), Seoul Civil Society Forum (Sept. 2011, Feb and Sept. 2012) and CIVICUS General Assembly in Montreal (Sept. 2011 and 2012).

CONCEPT NOTE

- 5. The ADA as a regional network of mainly NPs can be understood as a response to the common challenges facing national platforms in terms of their advocacy capacity building to participate effectively in the proliferated global agendas and processes (Post 2015, Post Istanbul, Post Busan HLF-4, Post Rio+20, G20 Development Agenda, etc.) as well as their domestic implementation. There has been a gap in information-sharing and agenda-setting between international and national levels as well as international norms and domestic reality on the ground. One of the main reasons identified was the lack of effective participation and capacity on the part of national CSOs especially national platforms or associations, as well as lack of effective mechanisms for systematic communication, consultation and coordination between international CSOs and national platforms.
- 6. To our knowledge, despite some efforts by international networks such as CIVICUS Affinity Groups of National Associations (AGNA), International Forum of National NGO Platforms (IFP) and others, a majority of national platforms in Asia are not yet fully engaged effectively in advocacy on international development discourse and policy formulation of international organizations such as UN, WB, ADB, OECD, etc. Democratic ownership and inclusive partnerships between national platforms and international CSOs networks remains a key challenge as many development issues are multi-dimensional and interdependent.
- 7. It is believed that national platforms in Asia can and should play a more proactive role at the regional and global levels as they have relatively richer resources and expertise which is in nature, multi-sectoral and thematic within the country. As an interface between international and national/local processes, national platforms are expected to contribute to closing a gap in cooperation with like-minded international CSOs/networks which are in nature sectoral and thematic. We believe that a synergy effect will be generated if and when three national platforms, national umbrella and international CSOs/networks are able to work together in strategic partnerships in action.

8. ADA currently covers three sub-regions, namely South Asia, Southeast Asia and Northeast Asia.

Main agenda

- 9. Main agenda of the ADA 2013 are three-fold Sharing, Analysis and Strategizing;
 - Sharing : sharing of experiences among national platforms about their activities regarding 'multiple post processes' and their advocacy work on enabling environment (political space, defending civil society, etc.)
 - Analysis : reflection on key international and regional issues, trends and challenges facing national platforms with focus on the international processes and meetings such as UN High-level Panel on Post 2015 Development Agenda and UN GA Highlevel Plenary (Sept. 2013), Global Partnership for Effective Development Cooperation (GPEDC), Rio+20 follow-ups including Sustainable Development Goals (SDGs), G20 Development Agenda, World Bank / Asian Development Bank (ADB), etc.
 - Strategizing : Making joint action plans based on common event calendar and designing sustainable facilitation and coordination mechanism.

Organizers, Sponsors and Coordination

- 10. The regional meeting of ADA 2013 is being initiated by 4 national platforms as coconveners – Voluntary Action Network in India (VANI) for South Asia, Cooperation Committee for Cambodia (CCC) and Code-NGO (Philippines) for Southeast Asia and Korea NGO Council for Overseas Development Cooperation (KCOC) for Northeast Asia in partnership with GCAP-Asia.
- 11. UN Millennium Campaign (UNMC) based in Bangkok and Asian Forum for Human Rights and Development (FORUM-ASIA), Bangkok-based regional human rights CSO network are to host the ADA locally.
- 12. Two international networks of national platforms and associations, namely CIVICUS Affinity Groups of National Associations (AGNA), International Forum of National NGO Platforms (IFP) and Good Neighbours International (GNI) are to join the ADA as cosponsors with their financial support.



- The need to reduce the 're-invention of the wheel' and improvisation in the leadership of NGOs/NPOs.


