Foreword from ADA Chair and Co-Chairs

Dear ADA Members Friends and Colleagues

Greetings of Solidarity!!

We are pleased to present ADA Annual Report 2020 for you. This report showcases ADA activities in last one year having three important focus areas: outreach, capacity building and advocacy by working with our members, partners and allies to realize rights and build resilience especially during the time of COVID-19 pandemics, that has confined civil society to the online space which is no panacea for democracy and human rights advocacy as the crisis is expected to last for some time with second and third waves already hitting us so hard. A diminished civic space relegated to the online realm reduces the effectiveness of civil society's contribution on this front. The movement restrictions has further added to the shrinking civic space in Asia. A phenomenon civil society has been experiencing in recent years as civil society operations have been curtailed by governments who use oppressive laws apart from cut off funding. Therefore, civil society needs support to become more effective in holding government accountable, advocating for civic and democratic reforms, fighting corruption, protecting human rights or fostering democratic participation.

ADA has been garnering all support from its members, partners and other rightsholder groups and has successful advocating on the shrinking civic and democratic spaces in various online forums with specific focus on SDG 16 plus. We came up with three publications including one on securing online space during last one year of pandemics highlighting that a human rightsbased approach can both improve the identification of problems, but also pinpoint the most effective entry points for SDG implementation, monitoring and reporting. While such an approach aims to protect poor and marginalized people by emphasizing their rights. more work needs to be done to highlight good practices. The use of citizen- led data and other sources of unofficial data and indicators could be useful tools to monitor progress with SDGs implementation, especially at the local level and thus strengthening support from governments towards enabling environment for civil society actors to actively engage in SDG monitoring and evaluation, including in the reporting processes.

Apart from its research based advocacy efforts, we have been consciously emphasising on capacity building approached during 8th and 9th GALA which were made virtual dure to the pandemics. The main aim of the training program were capacitating the civil society actors on various aspects on online security during 3 weeks SNS training program where the CSOs from across Asia-Pacific participated and later three months training program on SDG 16 plus. Both the training program led to two publications including an online guide and SDG 16 plus report (based on 13 countries case studies).



ADA has been very consciously working on the process of institutionalisation which was pointed out during 2019 and came up with its own constitutions though inputs from its steering committee members and rest of the ADA members in 2020. The ADA members also elected their new Steering committee members for 2020-2022 and later a process of ADA registration in Cambodia to have a global south focus.

We recognise that the our efforts would not remain the same without getting support from our members, trusted partner Forus and European Commission, JANIC and our continued support from TAP Network, Action for Sustainable Development, AGNA and CIVICUS and the UN institutions like ESCAP and UNDP Regional Hub, and most importantly our all national members and partners in Asia and other CSO partners from across the globe. We are also very thankful to the Code-NGO for their continued help and support in handling our financial matters and special thanks to the ADA secretariat, Steering committee and ADA advisors for their invaluable support and solidarity.

Together with our members and partners, ADA will continue to advocate for the rights of the people and civil society seeking equality for all. Some of the key highlights for 2021 would be training and capacity building programs on SDGs, especially SDG 16 Plus, digital civic space, advocacy papers and supporting and working in partnership with our members, partners and allies at various national and international forums to assure inclusive and participatory framework.

Executive Summary

The Asia Development Alliance (ADA) is a not-for-profit and non-governmental regional civil society platform in Asia, established on 2 February 2013 at the founding assembly in Bangkok, Thailand. The founding assembly aimed to (i) represent national CSO platforms in Asia; (ii) to serve as a key connector to national governments, UN organisations and other relevant stakeholders; and (iii) to create an enabling environment for civil society organisations and active citizenship.

The last one year witnessed the continued shrinking of civic and democratic spaces which has also reflected in the SDGs monitoring and implementation and later in VNRs preparation and presentation with few symbolic engagement processes during the time of pandemics. Although most of the VNRs dedicated a specific section on the principle of leaving no one behind (LNOB) and its meaning in their national context apart from highlighting the human rights based approach to development, they remain silent on human rights abuse , shrinking civic space and crumbling democracy. For example, despite an urgent call for action in Myanmar, we see stoic silence over the Junta oppression where more than 200 innocent lives have been lost in brutal ways since the military coup in the country.

Looking at these developments, ADA intensified advocacy for an enabling environment for civil society organisations to influence public policy at the national, regional and international level that are centered on democratic and human rights principles, as envisaged by the 2030 UN SDG Agenda.

During the last one year, ADA participated in more than 20 national, regional or international advocacy events in 2020 especially on mending Digital Apartheid during the time of pandemics, highlighting citizens led Data, steps to ensure a systematic data collection process by using both qualitative and quantitative data/information in national monitoring reports, lack of focus on tackling systemic barriers and little engagement in the transformative potential of the 2030 Agenda apart from tracking global economic policies that contradict the achievement of SDGs and recovery from COVID-19.

Last year, ADA intensified its approach and worked more closely with the UN ESCAP, UNDP, Global Alliances at the regional and global levels, participated and organized side events and worked closely with many Asian member state apart from the global CSO platforms like Forus, TAP Network, Action for Sustainable development, AGNA and many more.

ADA also added two new members from Timor Leste and Japan approved by its steering committee. We organized 12 Steering Committee meetings every month, which also elected its new Steering Committee for 2020-2022, apart from finalizing its constitution using participatory and inclusive mechanism involving all its members. ADA strongly believes that governments should strengthen a supportive, enabling environment for civil society actors to actively engage in SDG monitoring and evaluation, including in the reporting processes.



1. Introduction

Asia Development Alliance (ADA) is an innovative regional network empowering civil society for effective social change. It gathers around 30 national CSO platforms (NPFs) from South, Southeast, Northeast and Central Asia, altogether representing over 10,000 member organisations. ADA's long-term goal is to encourage Asian civil societies to increase their vigilance and collective efforts against violations of democratic and human rights ideals and addressing shrinking civic space.

ADA has advocated for an enabling environment for civil society organisations to influence public policy at the national, regional and international level that are centered on democratic and human rights principles, as envisaged by the 2030 UN SDG Agenda. ADA is recognized as a legitimate and mandated representative of the voice of CSO platforms across Asia.

ADA is also a regional network among members of Forus, CIVICUS AGNA (Affinity group of National Associations) and other global CSO platforms engaged in Sustainable Development Goals (SDGs).

Looking at the overall scenario in the last one year, it has been noticed that the global processes around the 2030 Agenda to date have seen unprecedented levels of engagement by civil society, and a growing engagement of civil societies and grassroots communities in the regional level, however, a significant gap still remains in the national level. We have also witnessed a setback in engagement in this era of COVID-19 and online engagement when the issue of wide digital divide hinders the meaningful participation of the poor and the most marginalised constituencies, and the collective efforts of the civil society to bring out grounded realities can be easily hindered by technological glitches, bypassed or skipped when the engagement takes place online. The last one year also witnessed the continued shrinking of civil society voices in the VNRs preparation and presentation with few symbolic engagement processes. Also, no VNR over 2017-2020 mentioned the issue of civic space and have been largely silent on this issue despite increasing calls for action by civil society organizations and others around the world to address the deteriorating human rights situation in many countries and protect human rights defenders and environmentalists. Moreover, the CSOs have been demanding a better engagement process with the government not only in the implementation but also on monitoring and review. The CSOs have also been demanding the governments to use the citizens led data in the view of continued data gaps admitted by the government.

Looking at the background, our activities in 2019 focussed around three core areas at the National, Sub-regional, Regional and Global levels, as per our commitments for the year.

a. Strong Governance and Accountability

ADA Constitution

In April 2020, <u>ADA constitution</u> was also finalized with support and inputs from ADA steering committee members, advisors and all ADA members, which was finally approved by online voting.

ADA has been organising a monthly steering committee for almost three years now to keep the governance board actively engaged. This has also smoothened the decision making process within ADA. The decisions regarding new members induction, advocacy efforts, ADA sustainability including fund raising opportunities, and meeting potential donors has been constantly discussed. The Steering Committee has been very conscious in their efforts to represent ADA in various external networks like Asia Democracy Network (ADN), Action for Sustainable Development(A4SD), Forus, TAP Network, Asia Pacific Regional CSO Engagement Mechanism (APRCEM) and others in a very responsible manner. This has further strengthened the bond between the secretariat and the Steering Committee, which is a good sign for ADA's governance transparency and inclusive participation.

b. Capacity Building on Strategic Planning

In 2020, we organized the following Training and Capacity Building Programs at national and sub-regional levels

• ADA – JANIC Social Networking Sites (SNS) Three Weeks online Training – (August 26 to September 10, 2020)





The SNS training is jointly organised by ADA and JANIC aiming at creating SNS campaigns addressing digital security and infographics to tackle potential human right violations

exploring digital infrastructure as they relate to civil society in democracies and shrinking civic space considering the role of privacy, anonymity, free expression and free association and examine the digital tools and practices that enable these freedoms. The training consisted of three

two themes:

- 1. The role of civil society in democracies especially in the context of continued shrinking civic space
- 2. Individual and collective digital security

Over 42 participants from Asia-Pacific participated in this training that focussed the digital civil society, its roles in democracy, and the political economy of Internet ecosystem apart from the lectures and discussion on the language of human rights and applications to the digital ecosystem threat modelling, digital privacy, authentication and protecting one's account . at the end of the training, each participant developed their own SNS manual , and the inputs were consolidated and .further developed into <u>SNS</u> toolkit.

ADA organised its 9th GALA training program on Linking SDGs with Democracy and Human Rights with a focus on SDG 16 Plus on 23-25 February 2021. The training program was



organised virtually due to the COVID Pandemic. <u>45 participants from more than 18</u> <u>countries</u> from Asia and Pacific participated. The training began with presentations on SDGs roadmap in Asia-Pacific by the UNESCAP followed by 18 countries presentations on SDG 16 Plus and 6 presentations on SDG nexus approach. The training program was made interactive and the participants were trained on forming SDGs 16 national indicators based on their country's context and existing global indicators. SDG 16 was the focus of the training program considering the fact that #SDG16 is the enabler and accelerator of all the other goals and a need to review the same just like SDG 17.



Overall Output of 9th GALA - 2021

10 participants (from India, Japan, Bhutan, Indonesia, Mongolia, Lao PDR, , Nepal, and Fiji) from the GALA2021 actively participated in the Asia Pacific Forum on Sustainable Development by being part of various thematic CSO factsheets and also participated in the plenary of Asia Pacific People's Forum of APFSD 2021, which is a great results as takeaway from the GALA.

c. Outreach and Advocacy

During the past one year of the global lockdown, ADA participated in more than 20 national, regional or international advocacy events in 2020. As a result of participation, ADA's visibility and outreach magnified both at the regional and the global levels. As a result of these advocacy initiatives, ADA has emerged as a strong regional CSO platform from the global south representing the national CSOs platforms from Asia , voicing up their concerns with great credibility.

ADA and member's alarm on COVID 19

During the past one year ADA has been connecting with its members to get <u>updates on COVID</u> <u>– 19 situation</u> in various Asian countries apart from endorsing and preparing its own statement. ADA has also been raising the issues of continued shrinking civic space during the era pf pandemics where the civil society voices have been muted in the name of technical glitches.

- Need to have established universal health care and universal social protection systems for better positioning to address the pandemic.
- Call for reduced military expenditures
- Vulnerable population groups must be placed at the centre of all social policy reform packages in the short- and medium-term.
- In long term, countries should invest to enhance emergency preparedness and strengthen social protection in order to enhance resilience of economies and minimize impact of potential health emergencies in future.
- Digital connectivity is making social distancing possible without social isolation. Investments need to be stepped up to reduce the digital divide.
