## SUMMARY

The Regional Coordinator will be responsible for the overall maintenance and development of the network and the design, coordination and implementation of programs and projects.

The Regional Coordinator is accountable to the Steering Committee (SC) through three Co-conveners.

All tasks should be conducted in compliance with the organization principles, requirements of partner organizations and country regulations.

#### RESPONSIBILITIES

- 1. Be responsible for the implementation of the decisions of Steering Committee as well as Co-conveners,
- 2. Be in charge of the implementation and coordination of the program and project(s) under his/her responsibility,
- 3. Organize the meetings and activities (e.g. capacity-building, advocacy, and campaign) as planned by the Steering Committee,
- 4. Communicate with members and partners through the website, newsletter, etc.
- 5. Handling administrative and financial matters
- 6. Other duties and tasks as assigned by Co-conveners when necessary

## KNOWLEDGE AND SKILL REQUIREMENTS

- 1. Committed, creative and passionate attitude to support advocacy actions of Asian CSOs
- 2. Professional experience in policy advocacy and good understanding of civil society and international mechanisms and processes on UN 2030 Agenda for Sustainable Development / Sustainable Development Goals (SDGs)
- 3. Excellent skills in event planning and project management
- 4. International working experiences with CSOs or International donors
- 5. Excellent communication and interpersonal skills
- 6. Ability to conceive, develop and complete tasks through distant communication without close supervision
