## **ADA and Members Activities**

#### **Regional Activity**

Creating a seat at the table - Workshop on engaging multiple perspectives for the 2030 Agenda , 23-25 August 2017, United Nations Conference Centre, Bangkok



The 2030 Agenda for Sustainable Development with its set of SDGs has been adopted inclusion and involvement of stakeholders is an important tenet of the agenda, in relation to both implementation process and outcomes (sharing benefits of development, leaving no one behind). The engagement challenge is both internal and external: Internal stakeholders include the wide array of ministries and agencies responsible for different areas of implementation and which may not all be aware of the 2030 Agenda, or may face different challenges in its full implementation. External stakeholders include the wider public, and others. In its formal engagement processes, the

United Nations has agreed to the designation of specific "major groups" as well as other stakeholders. Taking this as a background the UNESCAP had organized this meeting in Bangkok from 23-25 August at United Nation Convention Center, Bangkok where ADA was also one of those solicited participants to put forth its views from regional perspective.

It was observed that there is a strong interest from member's state to improve planning and prioritization for better engagement Impact and accelerate action, however there are many challenges that impacts the meaningful participation of stakeholders. At the same time, it was found that many countries in Asia-Pacific are struggling to get a clear road map. Hence a need of stakeholder mapping was also emphasized. It was highlighted that cooperation with shared vision can strengthen sustainable development. A transformative and holistic Regional Roadmap relies on addressing structural impediments and systemic barriers.

It must take into serious consideration targeted and sustained commitments on development finance and co-operation as well as inclusive collection and disaggregation of data to track the gaps and progress condition of the marginalized sectors. The role of civil society in outreach, information dissemination and capacity building on SDGs was also discussed apart from their challenges and barriers that they face in the community while capacitating them on the grass root level issues related to SDGs. Missing data is the biggest challenge in effective mechanism apart from accountability and resources in redefining SDGs to suit the national agenda.

## **National Activity**

National Workshop on UN Sustainable Development Goals (SDGs) d the role of civil society ,Ulaanbaatar, Mongolia, August 19, 2017

organised its ADA third national workshop on SDGs after Bhutan and Myanmar at Ulaanbaatar, Mongolia in partnership with Asia Democracy Network (ADN) International ,Korea Cooperation Agency (KOICA) and International Forum of National NGO/CSO Platforms (IFP) with Local Hosts : Mongolia Democracy Network (MDN), Open Society Forum (OSF) and the Center for Human Rights and Development (CHRD) in Mongolia. This training workshop was an initiative of



ADA to strengthen the advocacy capacity of civil society organizations in Mongolia on the implementation of UN Sustainable Development Goals at the national and sub-national/local level. Almost 52 civil society representatives from Mongolia participated in this important workshop. At the end of the workshop, the participants demanded a Mongolian translation of the Agenda 2030 so that decision makers don't focus on just one goal. The workshop also emphasized the need to engage with the government and forming coalition of CSOs for better advocacy at the national and regional and global levels.

#### South Asia Poverty Report: 2017, published by SAAPE

A triennial report on the poverty scenario in South Asian countries was released for the first time in north India at the Institute for Development Communication (IDC).

The report has been produced by the Nepal-based South Asia Alliance for Poverty Eradication (SAAPE). A Chandigarh-based study circle, 'Dialogue Highway', in collaboration with the IDC, facilitated the release of the report.
